

**OIL CAPITAL ROD & GUN CLUB, INC.**  
**LIABILITY WAIVER, RELEASE, AND COVENANT NOT TO SUE**

This Liability Waiver, Release and Covenant Not to Sue (hereafter "Agreement") is executed this \_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_ by and between Oil Capital Rod & Gun Club, Inc. (hereinafter "OCRG", and \_\_\_\_\_ (hereinafter "Signatory"). "OCRG" is understood to include its members, directors, employees, and agents.

1. Signatory asserts that he/she is knowledgeable regarding the operation and use of firearms and the dangers and risks associated with the use of firearms and is completely aware of all such risks. In consideration for the use of OCRG premises and/or its equipment **Signatory wholly and completely releases and extinguishes any and all past, present, and future claims he/she may have against OCRG relating to Signatory's presence on OCRG premises, use of OCRG equipment, and any activities engaged in by Signatory on OCRG premises, whether such activities are firearms related or not.** This release includes any and all claims of any kind against OCRG whether specifically described in this Agreement or not.
2. This Agreement is a waiver, release, and covenant not to sue given by the Signatory as consideration for being allowed the use of or presence on OCRG premises and property, and/or participation in OCRG activities. In the event of the institution of any future litigation, administrative proceedings, arbitration, or any other legal or equitable process whatsoever by Signatory, OCRG shall be unilaterally entitled to reimbursement from Signatory of all expenses associated with the defense of any such proceeding including OCRG's attorney fees. This Agreement is to be construed in accordance with the laws of Oklahoma, without regard to any choice of law provisions of Oklahoma. Oklahoma courts and tribunals are agreed to have sole jurisdiction and venue over this Agreement.
3. This Agreement does not obligate OCRG to provide any services or access on an ongoing basis, but any services or access provided to Signatory at any time are agreed to constitute valuable and sufficient consideration for this Agreement. Any changes or modifications to this Agreement must be in writing. Any part of this Agreement found unenforceable by a court or tribunal of proper and competent authority shall not nullify the remainder of this Agreement. This Agreement remains in effect unless cancelled in writing to OCRG, at which time, all privileges and access to OCRG and its property is revoked except to the extent required by law.
